## *Vehicle Operation – defensive driving and CoR*

### Units of Competency:

- TLIF1001 Follow work health and safety procedures

### Overview

This course consists of units of competency in the Transport and Logistics Training Package; it is delivered in a classroom environment, encouraging interaction and knowledge sharing between participants, with practical application of skills in an actual work environment.

Completion of this course may be used as a skills currency assessment or refresher for compliance or employment capability purposes.

### Who is this course for?

This course is targeted at licensed driver operators of heavy commercial vehicles.

Participants should have literacy and numeracy skills to the level of completing workplace forms.

### Course content

- Legislation, regulations and codes of practice
- Hazard and risk assessment and minimisation
- Workplace policies, procedures and industry best practice
- Defensive and efficient driving techniques
- Warning systems, controls and indicators
- Systems operations including tyres, steering, electrical and exhaust systems, brakes, fuel
- Identifying inconsistencies with optimum performance
- Undertaking pre-and post-operational checks and relevant document completion
- Height, width and mass limitations of bridges, tunnels and other structures
- Typical problems that may arise with technology used for navigation
- Breaches and consequences under CoR
